

Financial perspectives from the top – budget management and its impact AMIDEAST

- Small, regionally-specialized "3rd party provider" within a larger organization not specialized in Education Abroad; self-sustaining department and entirely dependent on tuition and fees
- Margins very small; every expense and every enrollment matters



- Most revenue goes directly to and remains in the countries of operation, i.e. in the MENA regions of the Global South
- Costs of housing and meals and some aspects of excursions are ultimately small, especially when compared with costs of instruction and staffing, and against similar costs in non-MENA/non-Global South countries



Financial perspectives from the top – budget management and its impact Western Kentucky University

- Student safety and well-being
- Moral obligations
- Legal obligation
- Institution reputation
- Keep office whole





Financial perspectives from the top – budget management and its impact Boston College

- Wide implications of COVID-19 across campus; education abroad is one part
- Need to consider reputation, i.e. may need to pay out more now to maintain good will
- Need to be flexible & go beyond what we have done before for refunds
- Recognition of the emotional toll of the crisis for all involved

The process to determine a refund policy Boston College

- Who has been involved?
 - All levels from international office to President
- What is the process?
 - Track what others are doing
 - Collect receipts
 - Determine recoverable expenses
 - Map out refunds across programs
 - Consider most vulnerable students
- How to communicate it once determined?
 - Message to parents & students





The process to determine a refund policy

- No refunds
- Programs were not "cancelled"
- We were halfway through the semester or more when students left; very little is recoverable or uncommitted
- The chaos of the final 3 weeks of the onsite portion of the program required great expenditure of financial, material, and human resources; contingencies cost more than normal program operations

The process to determine a refund policy

WKU

- Know institutional priorities, capacity and needs
- Consider full ramifications of the policy
 - At home
 - Abroad
- Establish basic principles, e.g.
 - Fair to all parties
 - No one profits
 - Minimize everyone's loss

- Communicate clearly before students commit
- Student's must acknowledge the refund policy
- Advise on cancellation insurance, if available
- Transparency in all processes
- Establish an impartial appeal process



Looking Ahead



- We are a global village of educators, we perish and thrive together
- International Education will not be the same after COVID-19, our principles will help reshape the future
- Evaluate vendor policies and agreements
- Develop mutual agreement, in writing, with partners



Looking ahead

AMIDEAST

THE

EDUCATION

- Temporary changes to financial policies for summer and fall programs so that students and sending schools have until a week before programs start to withdraw or cancel for a full refund
- Sending institution policies and decisions pose further threats to our ability to continue operating (i.e. cancelling summer and fall education abroad programs before we have to make a call as to their viability, etc.)
- Development of hybrid (virtual) semester with individual course options for fall 2020 and beyond

Looking ahead

Boston College

- Need to more clearly articulate refund policy for cancelled programs
- Make decisions on fall programs
- Update emergency response plan
